### **Brothers & Sisters:**

Mr. President and the New Jersey executive, honorable guest, BACDA-USA members, ladies and gentlemen, the National Executive wishes to thank you for taking time off your busy schedules to be here with us today. We also wish to thank all the members of the New Jersey chapter who have worked very hard to put this great event together.

My executive and I can not believe it has been two years since we accepted the challenge to lead this great association. Like the saying goes, time flies when one is having fun, and leading this association has been a lot of fun for us.

Leadership, as we all know, is as challenging as a war, and in every war some battles are won, others are lost. This was not different with this executive despite all our good intentions. Overall, however, we believe it has been a good two years.

### 1. The Houston Convention Update:

A year ago, our brothers and sisters in Houston together with each and everyone of us, worked hard to put together a great event. Hopes were raised, as we all looked forward to not only holding great deliberations but also having fun and raising funds for the Association. Unfortunately, based on the financial statement presented by the organizing committee in Houston, we lost money from the fund-raising events which were organized. We did get a few pledges and promises, but those too are still pending for various reasons.

### a) Proceeds from the Presbyterian Church:

The Presbyterian Church in Houston promised to channel the sum of \$2,200.00 through BACDA-USA to the Presbyterian Hospital in Nyassosso. This money has not been disbursed because the Church is reluctant to send cash to the hospital. I spoke with Mrs. Jane Strange and plans are underway for hospital equipment to be bought and sent to NyassossoHospital. The chairman of the Health Committee, Mr. Larry Metuge Ekaney, is working on a list of equipment to buy with Mrs. Strange.

# b) Pledge from Mr. Shelton Sparks:

Mr. Shelton Sparks of Boudreaux, Washington, and Sparks law firm in Houston pledged the sum of \$500.00 a year for an indefinite period to the Education Committee. We have not received these funds because Mr. Sparks needs a tax-exempt identification number from us to be able to declare this money on his taxes. Unfortunately, though a registered nonprofit organization with the District of Colombia we are still not yet in possession of a tax-exempt identification number.

Despite all the above, I would like everyone to remember the positive aspects of our convention in Houston, because BACDA-USA is listed in the records of the City of Houston since July 25th, 1998 was declared as a BACDA-USA day by Mayor Lee P. Brown. Our brothers and sisters in Houston lit a torch when they welcomed us in Houston last year and became BACDA-USA fourth chapter. My wish and hope are that they keep this torch burning even brighter than it did when they first lit it.

### 2. Incorporation:

There has been a lot of misconception about our status as a non-profit organization. Some have asked me whether we did become non-profit. The answer to this question is yes; we became a non-profit organization under the District of Colombia's Non-Profit Act. However, being declared a Non-Profit Organization does not automatically confer a tax exempt. We must fulfill the additional requirement of filing for a non-profit tax exempt identification number. The chairman of the Constitution Committee, Dr. Domenic Ntube and I will see to it that we accomplish this last but most important step for our Association.

### 3. BACDA-USA NEWS:

It is with great sadness that I inform you that our very able founding chairman of the Newspaper Committee Mr. Asome Bide, has tendered his ? temporary? resignation from BACDA-USA News.

BACDA-USA News saw its birth in Atlanta in 1995 when a very busy and struggling student had a goal to bring BACDA-USA in the limelight by proposing to start a Newsletter Committee. This proposal passed and he became the chairman of the committee he fought hard to start.

We have all been students in the United States at one time or another and many of us still are. We all know how difficult it is to juggle between school and a full-time job (because those bills must be paid). Mr. Asome had the unenviable task of juggling not only a full-time job, and a demanding Doctor of Pharmacy program, but also an increasing family and BACDA-USA News for many years. Did he succeed? You all know the answer, for we have all savored the fruits of his selfless labor. Today, he is asking for a temporary release from the duties of BACDA-USA News chairman, but promises to be back in the very near future.

On behalf of BACDA-USA, I would like to thank Mr. Asome for his dedication. I can not however end without thanking him on a personal note for his support to my administration both as a chairman and as a personal friend with a word of encouragement and praise here, a word of caution there, and a word of criticism where need be. I doff my hat for him and hope that we shall all emulate his exemplary commitment.

To the Atlanta members, I say thank you for showing my Ndu in-laws the importance of belonging to the Bakossi family and for showing me my efforts to keep us united are not wasted.
